VI. NEW BUSINESS:

A. Klooster identified this amendment was to the variance granted to Keith and Sandy Kelm of 514 Little Creek Trail on 5/13/2008. Klooster identified the fence was shown on the diagram that was submitted with the original variance documents, but the language - a variance to Chapter 3, Building and Construction, Article 3.1100, SECTION 3.1105 (b) was not. Klooster identified the documents for this amendment was presented to the adjacent property owners and there was no opposition. Mahlstedt made a motion to approve the amendment to the original variance granted on May 13, 2008 to allow for the fence for the horse paddock to be across the front of the property at 514 Little Creek Trail. Tuma seconded the motion. With the motion made, and seconded, Klooster asked Council if there were any questions. With no further questions or discussion, Klooster called for a vote.

Mayor Klooster called the workshop session to order.

X. WORKSHOP – BUDGET FISCAL YEAR 2008/2009

Mayor Klooster identified that the workshop was to review the proposed budget for fiscal year 2008/09. Council started an initial review of the proposed budget with discussion and changes as follows:

- Line item 4101 was to decrease from \$11,250 to \$5,000
- Line item 4202 was decreased from \$17,140 to \$15,000.
- Line item 4205 was decreased from \$2,264 to \$2,000.
- Line item 4300 was decreased from \$9,150 to \$9,000.
- Line item 4304 was decreased from \$3,200 to \$3,000.
- Line item 4400 was increased from \$291,013 to \$300,000.
- Line item 4402 was decreased from \$14,025 to \$8,000.
- Line item 44022 was decreased from \$3,500 to \$2,000.
- Line item 5100 was increased from \$22,000 to \$35,000.
- Line item 5117 was decreased from \$27,000 to \$20,000.
- Line item 5119 was decreased from \$61,321 to \$58,850.
- Line item 5122 was increased from \$25,000 to \$140,000.
- Line item 5208 was increased from \$1,000 to \$2,000.
- Line item 5301 was decreased from \$2,000 to \$0.00.
- Line item 5302 was increased from \$2,400 to \$3,000.
- Line item 5504 was increased from \$3,000 to \$30,000.
- Line item 5505 was increased from \$1,000 to \$3,000.
- Line item 5506 was decreased from \$52,000 to \$0.00
- Line item 5509 was decreased from \$2,000 to \$0.00.
- Line item 5602 was decreased from \$12,250 to \$10,000.
- Line item 5604 was decreased from \$1,200 to \$0.00.
- Line item 5801 was increased from \$600 to \$700.
- Line item 5904 was increased from \$2,130 to \$3,000.

Klooster further identified that there would be another budget workshop possibly scheduled on July 15, 2008. Before or after the Regular City Council meeting.
